1. The student hereby applies for membership of Ring Contact Fighting Arts, subject to the terms and conditions mentioned hereinafter.
- 2.1 The student admits that he/she is aware of the fact that, if this application is accepted, he/she will be subjected to severe physical exercise and training for which sound physical health and a high degree of fitness is required. The student further admits that he/she is aware of the fact that Ring Contact Fighting Arts is a potentially dangerous sport and, accidents and/or injuries may occur.
- 2.2 The student accepts all risks involved in the practicing of Ring Contact Fighting Arts, and hereby indemnifies the instructor and any controlling body or organization, or any member or official, against any claims due to the student's participation in Ring Contact Fighting Arts.
- 2.3 The student confirms that he/she is in good physical health and that he/she is not aware of any physical conditions or disability which may hold any risk for him/her with regard to him/her being trained in or practicing Ring Contact Fighting Arts, except for the following (give full particulars):

3. An annual registration fee of R200,00 is payable by the student within seven days after registration (but in any event before training commence), over and above any fees which may be payable to the instructor/club personally in terms of any agreement between the instructor/club and the student or fees payable to enter into any tournament, etc, which registration fees will be subject to such increases as may be announced from time to time. The student also undertakes to furnish the instructor with two passport photos of him-/herself within the aforementioned period. The student will remain liable for the payment of training fees, and any other financial commitment, until this agreement is terminated, notwithstanding the fact that the student did not for any reason whatsoever attend training sessions.

4. The student hereby consents to be trained according to the RCFA syllabus in the following categories:

- 5.1 The student will not, without reasonable excuse, fail to attend training, and undertakes to notify the instructor should he/she be unable to attend more than one successive training session.
- 5.2 The student will readily submit him-/herself to any reasonable instruction or request of the instructor or other official.
- 5.3 The student undertakes to submit him-/herself to all regulations regarding the Ring Contact Fighting Arts Constitution, Policies, Procedures, Syllabus of Ring Contact Fighting Arts and accepting and abiding by the terms and conditions of and to any disciplinary action, which may include warnings, fines, or suspension.
- 6.1 This agreement:
- 6.1.1 will terminate on 31st December of the year in which it was signed.
- 6.1.2 may be terminated or suspended immediately should the student fail to comply with any term or condition thereof.
- 6.1.3 may be terminated at any time by either party with one calendar month notice to the other party in writing.
- 6.2 Should this agreement be terminated or suspended, the student will not have the right to claim a refund in respect of any monies already paid, and the student will remain liable to pay all monies which may be due and payable on the date of such termination or suspension.
7. Should the student be a minor, his/her lawful guardian must sign this application. The guardian confirms that the information contained herein is correct in all respects, and that all representations, warranties, indemnifications, and undertakings contained herein will be binding on the guardian, and that the guardian will also not have any right of recourse as contemplated in clause 2.2.
8. The student hereby agrees and consents to provide his/her personal information to Ring Contact Fighting Arts, as required under Section 11(1)(a) of the Protection of Personal Information Act 4 of 2013 (“POPI”) and hereby authorizes Ring Contact Fighting Arts to release and use his/her personal information including all photographs or electronic images solely for the purpose of marketing and promoting Ring Contact Fighting Arts or any legally required purpose.
